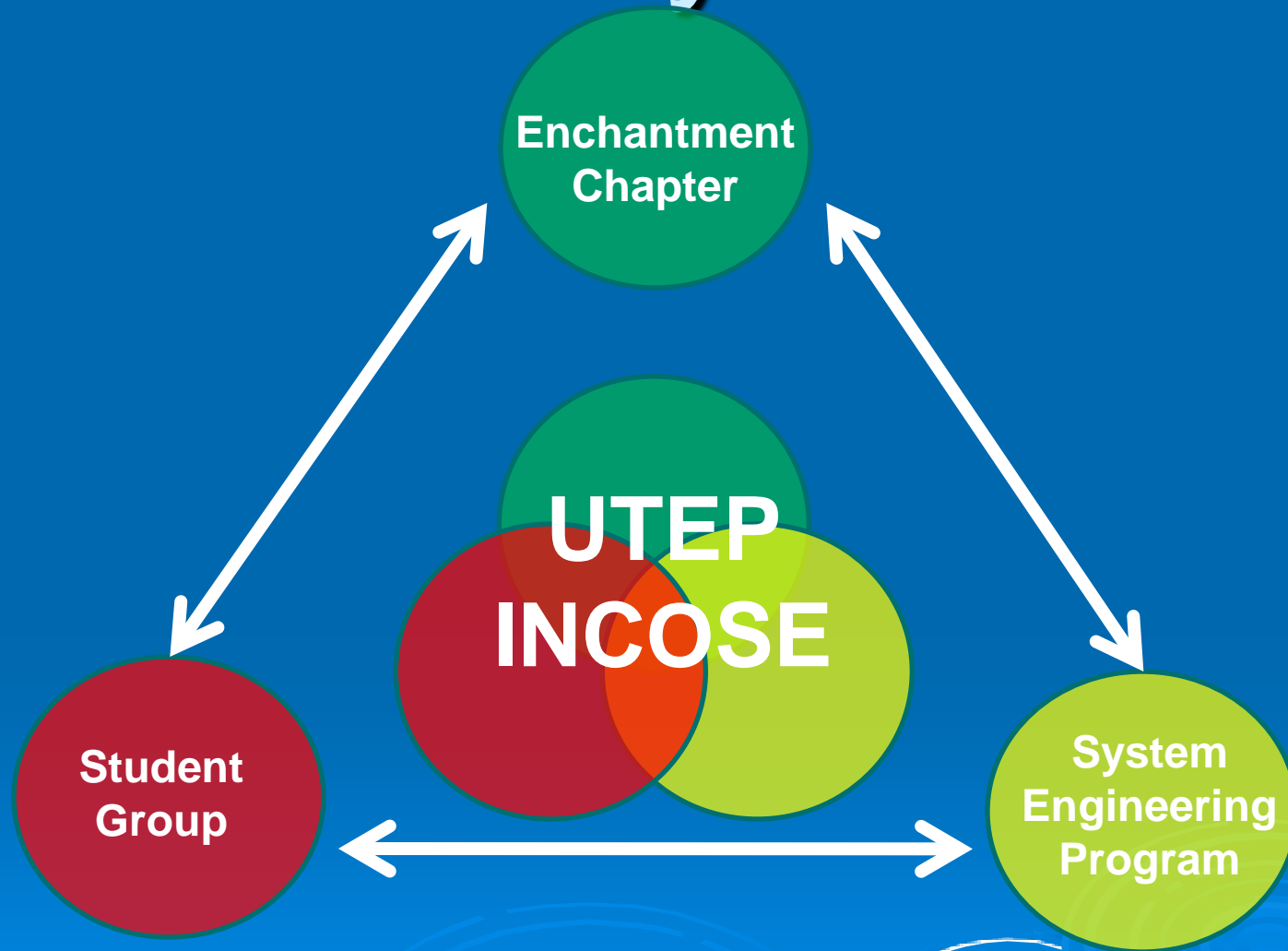

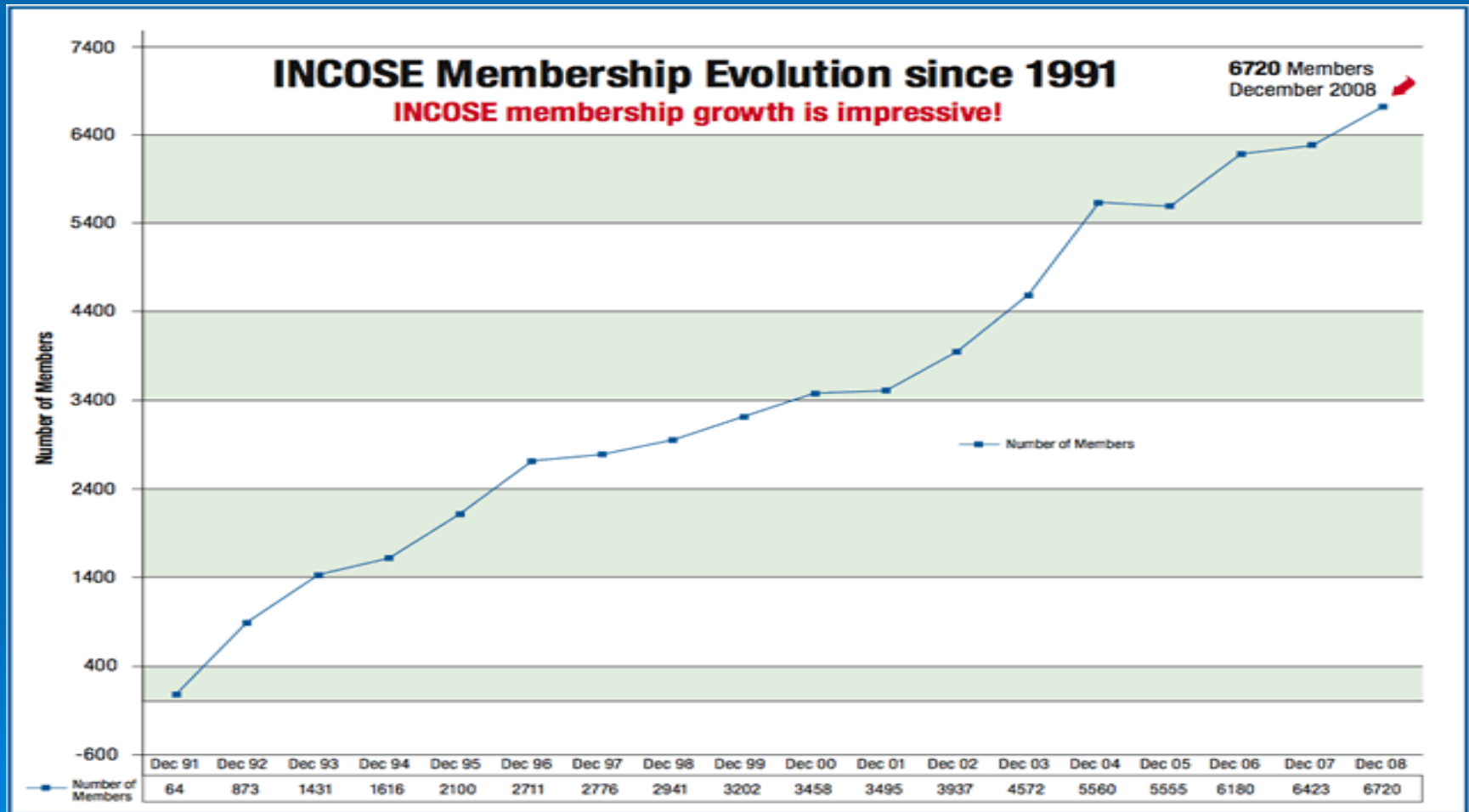

# Officers Roles

- The President shall:
  - Carry out the purpose of INCOSE as in Article II .
  - Call for Special and Executive Committee Meetings.
  - Be responsible for supervising all events and conduct all meetings accordingly.
  - Coordinate activities with other officers.
- The Vice President shall:
  - Assist the President in supervising all activities of the Student Division of INCOSE.
  - Temporarily assume the functions of the President when so requested by the President or if the President has resigned.
  - Carry out the purpose of INCOSE as in Article II .

# Officers Roles

- The Secretary shall:
  - Prepare and maintain the minutes for all meetings.
  - Be responsible for keeping all the correspondence of the Student Division of INCOSE.
  - Maintain membership lists.
- The Treasurer shall:
  - Maintain records of all the financial transactions of the Student Division of INCOSE.
  - Collect and deposit all funds received on behalf of INCOSE in a UTEP account.
  - Prepare a financial statement for INCOSE and present it to the members.

# Officers Roles

## ➤ The Presidential Elect Shall:

- Shall be the successor for the upcoming year to hold office as President of the organization.
- Assist the President in supervising all activities of the Student Division of INCOSE.
- Carry out the purpose of INCOSE as in Article II .
